

## 1--APPLICATION

Application, No. Adm/Gen/A-13/730, dated 26th August, 1974, from the Principal of the Smt. Mithibai Motiram Kundnani College of Commerce and Economics, Bandra, Bombay-50.

Subject: Permanent affiliation of Smt. Mithibai Motiram Kundnani College of Commerce and Economics for teaching courses of study leading to the B.Com. degree examination with the special subject of Business Management.

Sir,

I have the honour to apply for the Permanent affiliation of Smt. Mithibai Motiram Kundnani College of Commerce & Economics, Bombay for the teaching of courses of study leading to the B.Com. Degree examination with the special subject of Business Management.

2. The college was granted permanent affiliation for the teaching of courses of study leading to the B.Com. degree examination with the special subject of Accounting and Auditing with effect from June 20, 1969. Affiliation for the teaching of courses of study for the B.Com. degree examination with the special subject of Business Management was first granted for 2 years with effect from June 20, 1969 and last extended for 2 years with effect from June 16, 1973. As this period of affiliation will expire on June 15, 1975. I request that the college be granted permanent affiliation to the University for the teaching of courses of study with the special subject of Business Management.

3. Information required under section 50(I) of the Bombay University Act, 1953 is given below:

(a) The college continues to be under the Management of Hyderabad (Sind) National College Board, which is a properly constituted governing body, registered under the Societies Registration Act of 1860 and has been recognised as such by the University;

(b) The number and qualifications of the teaching staff and the conditions governing their tenure of office are such as to make due provision for the courses of instruction, teaching and training to be undertaken by the college. The list of the members of the teaching staff working in the department of Business Management together with the details of their qualifications, salary etc. is attached. (Appendix A).

(c) The college is housed in a suitable building with adequate accommodation for a full fledged degree college. The building is also properly furnished;

(d) Adequate provision has been and will continue to be made for the Library;

(e) Does not arise;

(f) The Principal of the college resides in a flat provided on the third floor of the college building;

## II—REPORT OF THE LOCAL INQUIRY COMMITTEE

Pursuant to your letter No. Aff/Recog./21574-76, dated 6th December, 1974, we formed ourselves into a committee to make a local inquiry in respect of an application No. Aff/Gen./A-141730, dated 26th August, 1974 from the Principal of the Smt. Mithibai Motiram Kundnani College of Commerce and Economics, Bombay, for the permanent affiliation of the college for the teaching of the courses of study for the B.Com. degree examination, with the special subject of Business Management. We visited the college on Wednesday, 15th January, 1975. We were received by Principal N. K. Bhojwani. We have to report as under.

The College which was granted permanent affiliation for the teaching of the courses of study leading to the B.Com. degree examination with the special subject of Accounting and Auditing with effect from 20th June 1969, started the teaching of the subject of Business Management from the academic year 1969-70. The number of students in the subject in the Senior B.Com. classes this year is 17 in the morning session and 25 in the day session.

**Staff** :—Principal N. K. Bhojwani who holds B.A. (Hons.) and B.Sc. (Lond.) degrees and who has 18 years teaching experience is the Professor and Head of the Department of Business Management. He teaches Paper-I-Principles of Management. Though he does not possess any formal qualification in Business Management, he has rich experience of Public Administration and Management Training. In view of this the previous local inquiry committee had considered him suitable for holding the post of Professor and Head of the Department of Business Management but had expressed a view that it would be desirable to appoint a full-time Professor as Professor and Head of the Department of Business Management and had pointed out that though the work-load in Business Management did not demand the appointment of such a Professor, such a professor could be entrusted with the teaching of other commercial subjects as is being done in other commerce colleges.

The teaching of Paper-II-financial Management is entrusted to Shri D. S. Khankhoje, B.Com., C.A.. He is a part-time Professor and Head of the Department of Accountancy and is in the grade of Rs. 350-550.

The subject of Marketing and Sales Management (Paper-III) is being taught by Shri Sidney Babha Miranda who is a Visiting Professor and who has been assigned two periods in Marketing and Sales Management. The appointment of a part-time professor of Marketing and Sales Management has not been made. It may be stated in this connection that the Local Inquiry Committee which was appointed in the year 1970 to make a local inquiry in connection with the application from the Principal of the M. L. Dahanukar College of Commerce for continuation of affiliation of the college for the teaching of the courses of study leading to the B.Com. degree examination with the special subjects of (1) Accounting and Auditing (2) Banking and Finance and (3) Business Management had recommended as follows :—


"We realise that there may be difficulty in obtaining the services of practising managers as part-time teachers. However, with efforts and suitable adjustment of time-tables, it should be possible for the colleges to secure the services of practising experts employed in commercial and industrial firms. In order to enable the colleges to do so, we recommend to the Syndicate that the normal rule that a person who holds a full-time appointment elsewhere should not be appointed as part-time teacher may be waived in the case of subject of Business Management in the interest of development of the teaching of this subject in Commerce Colleges".

The Syndicate on the recommendation of the Academic Council decided that the directive referred to in the recommendations of the Local Inquiry Com-
