Fee Refund Policy of the Academic Year 2024-25

WHEREAS, the college has been adhering to the provisions outlined in the UGC Notification of Refund of fees & Non-Retention of Original Certificates, 2018, and fee refund of Policies/Guidelines issued from time to time. In accordance with these provisions, the college has been refunding the fees to student who cancelled their admissions.

AND WHEREAS, the University Grants Commission (UGC) has issued a policy regarding the Fee Refund for the Academic year 2024-25 on June,12, 2024/22 जेष्ठ,१९४६ vide circular No. D.O.No.F.2-71/2022 (CPP-II) (C-114546), outlining the procedures for the refund of fees due to cancellation of admission/migration of students for the Academic Year 2024-25.

NOW THEREFORE, it is hereby informed that the College will refund fees according to the provisions stated in the UGC refund policy dated 12th June, 2024 for the Academic Year 2024-25 as mentioned below:

- **a.** Notwithstanding anything contained in any guidelines/ prospectus/ notification/ schedule, a full refund of fees shall be made by the HEIs on September 2024 and with a deduction of not more than Rs.1,000, as a processing fee, up to 31st October 2024.
- **b.** For any admission schedule extending/ commencing beyond/ after 31st October, 2024, the provisions contained in the UGC Notification issued in October 2018 on Refund of Fees and Non-Retention of Original Certificate shall apply (reproduced below for ready reference):

c. This policy will remain in force for subsequent academic sessions until the issuance of a revised policy by the UGC.

* The refund will be transferred to the same bank account that was provided during the online application for admission cancellation. The College is not liable for any delays or errors due to inaccurate provided by the student.
